**1. Submission.**

Tenders must be accompanied by a Bid Security of **Kshs 10,000,000.00** (Kenya Shillings, Ten Million only) of the contract sum from a reputable bank or insurance firm approved by PPRA valid for an **additional 30 days** beyond the tender validity period.

Bidders are required to submit **One (1 No.) Original** and **Two (2 No.) Copies** of the bid document and each page of the bid submitted should be **duly serialized/paginated, well bound and intact**.
